#### 2009 CLTA conference

Jason Harris and his team from the UTS Law School provided a vibrant conference in an exciting inner city location at the UTS campus as Haymarket. The conference was organised amid some challenges including the GFC and tightened university budgets. Despite the pressures and challenges during the conference, Jason was calm, courteous at all times. He shouldered an enormous workload at the conference, including introducing our visiting plenary speakers, he chaired sessions, presented a paper himself. His services to the membership are noted and greatly appreciated. The conference theme perhaps foreshadowed these challenges: 'Raising Confidence in the Capital Markets through Gatekeeper Accountability: Lessons from the credit crunch'. Consistent with this theme, every attempt was made to keep the conference 'affordable' at \$300, quite an achievement in an expensive city.

The 2009 CLTA Conference opened with what was a truly celebratory occasion for the Association – cocktail party for the presentation of medallions and certificates to members, recognising past service to the Association. The event was in the pleasant courtyard area of the Law school at Haymarket. IP president Jean put in a lot of effort to design the awards and thorough research to ensure that since the first conference in 1991, appropriate recognition was given to the members who served the Association. The Conference itself was opened on Monday morning by the Dean of UTS Professor Jill McKeough. The conference key noted two high profile speakers, Satyajit Das on Monday and Professor John Lowry, University College London on Tuesday.

Das, who amongst other things is a former investment banker, was particularly provocative in his address examining some of the financial crisis indicators brought about the market for debt. The conference materials provided to each participant also included a copy of Das' book, Traders, Guns & Money: Knowns and Unknowns in the Dazzling World of Derivatives (2006, FT-Prentice Hall), an insider's account of derivatives trading and the financial products business filled with black humour and satire. Das was quite generous with his time in taking questions and comments from the floor. We thank Prof Paul Redmond in particular in securing Das' participation in the conference.

John Lowry, Professor University College London, led a plenary discussion on the statutory codification of directors' duties in England. His talk pointed out several potential inconsistencies and ambiguities in the present statutory formulation. The talk generated a lively debate about the formulation of directors' responsibilities at common law and under statute.

The UTS conference also featured the highly topical and popular "Panel Discussion", addressing the conference theme, 'Raising Confidence in the Capital Markets through Gatekeeper Accountability: Lessons from the credit crunch'. The Panel was moderated by Professor John Stumbles UTS and we were fortunate to have attracted to our Panel high calibre practitioners and industry leaders. The conference attracted over 70 delegates from Australia New Zealand and our region. Many of the sessions were chaired by UTS faculty and we thank them for their assistance. The papers, as usual, were an interesting mix of topical and challenging research issues, such as governance, directors' liability, external administration, market law and market manipulation, remuneration, law reform theory and agendas, shareholder claims.

Once again we had as an adjunct to the research program an optional teaching session.

The CCH Conference Dinner at Zilvers restaurant, Haymarket, comprised a Chinese banquet, which was appropriate for UTS law school location and the time of year, being proximate to Chinese new year.

The Best Paper Prize(sponsored by the Chartered Secretaries Australia), announced at the conference dinner, was awarded to three joint authors Abe Herzberg, Mark Bender and Lee Gordon-Brown (Monash University) with a paper titled "Characteristics of companies that enter into voluntary administration". The Second Prize (sponsored by Oxford University Press) was awarded to Michelle Welsh (Monash University) wit a

paper titled "Continuous disclosure: Testing the correspondence between state enforcement and voluntary compliance".

Apart from our major sponsors (Chartered Secretaries Australia and CCH), the sponsorships of Thomson Reuters, LexisNexis Oxford University press are gratefully acknowledged. Three of the sponsors, CCH, LexisNexis and Thomson Reuters provided members with book displays and their friendly academic representatives were on hand for the members throughout.
