2014 CLTA Conference

The 2014 Conference was hosted by the Adelaide Law School at the University of Adelaide and held on 2-4 February 2014. Dr Suzanne Le Mire and Associate Professor Chris Symes organised the event. The event was both thoroughly intellectually engaging and convivial.

The theme for the conference was "From Corner Shop to Large Multinational: The Governance, Regulation and Rescue of Corporations" and invited participants to consider the challenges inherent in regulating for the diverse types of corporations. The conference was organised to promote scholarship in the following streams:

- Regulators and Regulation
- The Future of Corporate Law
- Corporate Governance
- Insolvency
- Ethics in the Corporate Sphere.

Andrew Keay, Professor of Corporate and Commercial Law at the University of Leeds, was the keynote speaker. Professor Keay, one of the world's leading corporate governance scholars, spoke on the topic of 'Exploring the Rationale for Board Accountability in Corporate Governance". The plenary session on Tuesday was entitled "Hot Issues for the Small End of Town" and involved a stimulating discussion of the operation of corporate law for small business. It featured Mike Sinkunas, the Small Business Commissioner of South Australia, Rosey Batt of Rosey Batt and Associates, Alex Mezhvinsky of ABR Finance and Franc Camatta of Camatta Lempens.

Other highlights of the conference included two plenary panels on the first day that were entirely populated by women. From recollection, these were the first all-female panels in the history of the CLTA conferences. The first session was entitled "The AGM and Shareholder Engagement". It was chaired by Suzanne Le Mire and the panellists were Judith Fox from the Governance Institute of Australia, Jennifer Hill from the University of Sydney and Gill North from the University of Western Australia. This was followed by a panel session entitled "Revisiting a Classic: Hansmann and Kraakman "The End of History for Corporate Law". I was very honoured to chair this second all-female panel and its panellists were Irene Lynch Fannon, Kath Hall and Michelle Welsh.

The CCH Conference Dinner was held in salubrious style in the Gallery Room at the National Wine Centre. The Best Paper Prize, sponsored since its inception by the Governance Institute of Australia (formerly the Chartered Secretaries Australia), was awarded to Francesco de Zwart of Adelaide University, whose paper "Enron and Hastie: What can we learn?" was subsequently published at (2014) 29 Australian Journal of Corporate Law 169.

We are delighted that a leading US commentator on corporate governance, Professor Robert Thompson from Georgetown Law School, will be speaking at the conference.

2014 Best Paper Prize

Every year one paper is selected from the annual conference for the best paper prize. A full description of the terms of the award can be found at the CLTA website. The prize is designed to encourage scholarship by authors at senior lecturer level or below. Accordingly, papers submitted where any authors' appointment is above senior lecturer (or equivalent) are ineligible for the prize. The eligible papers must be submitted by a certain date which is nominated in the call for papers, usually 2-3 weeks prior to the first day of the conference. This year we had a record number of papers that were eligible for the prize so it is very pleasing that there is such interest in both the conference and the prize.

The Best Paper Prize will be presented at the CLTA Conference Dinner at Melbourne Town Hall by Ms Judith Fox (National Director, Policy & Publishing) on behalf of our major sponsor, Governance Institute of Australia Ltd.

2015 CLTA Conference Bursary

Our bursary program, which offers financial support to enable HDR candidates to present a paper at the conference, provides a valuable opportunity for HDR scholars to share their research with corporate law scholars. There are generally two bursaries awarded each year to a local recipient of the host university and an external recipient.
