Professor Farrar is currently Emeritus Professor of Law at Bond University (2013). He commenced his academic career in 1969 and has been in academia continually since then apart from three years when he was with the law firm Bell Gully Buddle Weir. His academic career has therefore extended over 40 years. He has been Dean of three law schools – Canterbury, Bond and Waikato and was also Acting Vice Chancellor of Bond University in 1995-1996. Professor Farrar has published extensively in corporate law - including more than a dozen books and many book chapters and journal articles. He has also been active in law reform. A notable feature of Professor Farrar's contributions to corporate law – whether teaching, publications or law reform, is that they have involved significant contributions in three countries – Australia, New Zealand and the UK. Professor Farrar has also made important contributions to the CLTA. Bond University has hosted two CLTA conferences – in 2012 and 1996 and Professor Farrar has also been a member of the Executive Committee. Professor Farrar was made an honorary life member of the Australasian Law Teachers Association in 2008 for services to legal education.

Professor Farrar has the following degrees: University College, London, LLB (Hons); University College, London, LLM; University of Bristol, PhD; University College, London, LLD. He has held senior academic appointments in three countries: Senior Lecturer, University of Bristol; Professor of Law, University of Canterbury, New Zealand; Professor of Law, University College, Cardiff; Professor of Law, Victoria University of Wellington; Harold Ford Professor of Commercial Law, University of Melbourne; Professor of Corporate Governance, University of Auckland.

Professor Farrar has held visiting positions at the Universities of California (Berkeley), Cambridge, Ghent, Hong Kong, Peking, Sydney, Toronto, Tsinghua and Western Ontario.
